Age Limit:

- a) The age should be between 18 years to 30 years as on $\underline{07.01.2014}$ which is the closing date of receipt of application.
- b) There will be no age limit for the employees of the Council for the above said posts.
- c) The above quoted upper age limit is relaxable in case of SC/ST/OBC as permissible under the rules (5 years for SC/ST, 3 years for OBC).
- d) Age relaxation to PH and Ex-serviceman candidate shall be admissible as per rules.
- e) The crucial date for determining the age limit and qualification in each case will be the closing date for receipt of applications from candidates.

GENERAL INSTRUCTIONS FOR THE ABOVE POSTS

- 1. The prescribed essential qualifications are minimum and enhanced qualification does not entail candidates to be called for written test/practical test/interview. Where the number of applications received in response to the advertisement are large and it will not be convenient or possible for the Institute to call all those candidates for written test/practical test/interview, the Director, IVRI, Izatnagar reserves the right to fix the criteria for calling the candidates on the basis of qualification, experience etc. After screening the applications, the candidates will be called for written test/practical test and interview as the case may be.
- 2. These posts are non-government under the Indian Council of Agricultural Research, which will be governed by New Pension Scheme 2004 introduced by the Government of India with other service conditions mutatis-mutandis and as amended from time to time.
- 3. All posts are temporary but likely to continue. Candidates must ensure that they fulfill all the eligibility conditions for these posts with regard to qualifications and age.
- 4. Persons already in employment should route their application through proper channel.
- 5. No correspondence will be entertained from any candidates for selection/test/interview/ appointment. Canvassing in any form will be treated as disqualification.
- 6. Candidates applying for more than one post will have to submit separate applications for each of the post.

- 7. Candidates are advised to send attested copies of each certificate or any other authentic document in support of their age, mark sheets and certificates towards educational qualifications and caste certificates in respect of their claim etc. with their application, failing which their applicability will be rejected.
- 8. The application should be submitted to the **Asstt.Adm.Officer** (**MRDPC**), **Indian Veterinary Research Institute** (**ICAR**), **Izatnagar-243 122** (**UP**) within the due date of closing, i.e. <u>07.01.2014</u> in the Prescribed Type-written Proforma accompanied by a latest passport size photograph alongwith Examination fee (**Non-refundable**) of **Rs.200/-** (**Rupees Two Hundred only**) for each post to be sent in the shape of Bank Draft drawn in favour of "**ICAR**, **UNIT-IVRI**" payable at Izatnagar. <u>The name of the candidate, father's name and the post applied for should be mentioned on the backside of the Bank Draft. Candidates belonging to <u>SC/ST/Femal candidate & PH are not required to pay any fee.</u> No fee exemption is, however, allowed to the OBC candidates. - 9. Application not accompanied by the prescribed fee as per requirement or incomplete or defective or unsigned declaration or without attested copies of their certificates i.e. without proof of qualification, age, caste certificate etc. shall be summarily rejected.
