#### (3) **AGE LIMIT:**

### **COMPENSATION PACKAGE:** (5)

During one year training period, the selected candidates will be placed as Officer Trainees / Engineering Trainees at initial Basic Pay of Rs. 16,400/- per month in the Pay Scale of Rs. 16,400 - 40,500/- (E-1) with applicable D.A. The trainee Officers/Engineers will be posted at any of the MECL Projects / Zonal Office / Corporate Office of the Company.

On successful completion of one year training, Officer Trainee / Engineering Trainee shall be regularized as Geologist, Geophysicist, Chemist and Drilling Engineer, as the case may be, and they will be placed at a basic pay of Rs. 16,900/- in the scale of pay of Rs. 16,400 - 40,500/-.

### **RELAXATIONS / CONCESSIONS: (7)**
