The Ph.D. Entrance Test will be held **on 25 February 2014, 9 am to 1 pm** at the Institute Main Building in the Institute's Campus at Mesra, Ranchi 835215 (except those candidates who wish to join the Ph.D. programme (Session Spring 2014) at its other Campuses, the venue for the Test & Interviews will be the same Campus). The candidate must indicate the Choice of Campus in their Application Form.

Please see web notification for details. Candidates must carry valid Photo ID at the time of Test.

(Driving license, Passport, PAN Card, Voter ID, Employee Identification Card are acceptable)

Date and Venue for Interviews: 25 February 2014, from 2 pm or after publication of the result of Written Test, at the concerned Department / Campus

List of enclosures required with the Application Form:

Candidates must attach one recent colour passport size photograph, identical to that affixed in the application form. Candidates must attach photocopies of the following documents with their duly completed Application Form:

- 1. Pass certificate and marksheet of Class 10
- 2. Marksheet of Class 12 / Intermediate or equivalent
- 3. Certificate and marksheets of Graduation
- 4. Certificate and marksheets of Post Graduation
- 5. College Leaving Certificate and Migration Certificate
- 6. Candidates with qualifications acquired through correspondence or distance-learning programmes are eligible only if (a) they acquired such qualifications as working professionals / while in employment, (b) the programmes are recognized by the DEC-UGC-AICTE or MHRD, (c) they have passed the qualifying examination at the time of applying, with minimum requisite marks as given in eligibility criteria. They must enclose photocopies of (i) work experience certificate (ii) pass certificate and marksheets of qualifying examination with their application.
- 7. CSIR-NET / BRNS/ NBHM/ GATE / GPAT 2013 admit card and Score card (if applicable)
- 8. Caste certificate / special category certificate (if applicable) in proper format (see below)
- 9. Sponsorship letter, NOC, Experience Certificate and Facilities available to carry out the research work at their place of working (if applicable) for Sponsored / Part-Time candidates
- 10. Photo identification: (Driving license, Passport, PAN Card, Voter ID, Employee Identification Card are acceptable)

Write your Name, your telephone number and Ph.D. Spring 2014 on the back of each of these documents and certificates. All such papers must be stapled or stitched to the form.

- All candidates belonging to the SC, ST categories must obtain caste certificates which should be in proper format, and which should be signed by appropriate authority of rank not less than SDO. (Note: Final reservation proportion will depend on notification, if any, issued by competent authority and as accepted by the Institute).
