## Admission Notification for MD/MS and other PG Diploma Courses and MDS Courses

(Admission Notification No. 01-BOPEE of 2014 Dated: 05-01-2014)

Online applications are invited from permanent residents of J&K State who are eligible and desirous of appearing in the Entrance Test for admission to **MD/MS/PG Diploma Courses** in Government Medical Colleges of the State, SKIMS-Srinagar & ASCOMS-Jammu and **MDS Courses** in the Govt. Dental College, Srinagar. The selection of candidates will be governed by the rules and guidelines as contained in the Electronic Information Brochure-2014 available on the official websites of the J&K Board of Professional Entrance Examinations.

### Availability of Online Application Forms

The Applications are to be submitted online only through BOPEE websites [www.jkbopee.in](http://www.jkbopee.in) or [www.jakbopee.org](http://www.jakbopee.org) or [www.jakbopee.net](http://www.jakbopee.net) from 08<sup>th</sup> to 22<sup>nd</sup> January, 2014. The fee for online submission is Rs. 1800/= (Rupees one thousand eight hundred only) which can be submitted in the form of Bank Draft favouring FA/CAO BOPEE, payable at Srinagar/Jammu or Customised Bank Challan of transfer of the said amount in the BOPEE's HDFC Bank Account No. 50100006864332 specified on the online generated Customised Bank Receipt at the end of submission of online form.

The Online Rehearsal Facility for submission of application forms will also be available from 06<sup>th</sup> to 07<sup>th</sup> January, 2014. No application submitted during rehearsal will be accepted for Entrance Test.

The applicants are advised to fill the online application forms on their own or through a responsible person. The applicants can also avail this facility at the **Help Desk** of I.T. Section of BOPEE with prior telephonic appointment (on 9469012295 for Jammu & 9419434133 for Kashmir) on nominal fee of Rs. 100/= on all working days. They are also advised to get along with them all the required documents in original and two photographs so that they may submit online application form complete in all respects on the same day at the respective BOPEE offices.

### Receipt of Online Application Forms

The Confirmation Page of online application forms along with prescribed photographs, required certificates and bank draft/bank challan shall be received at Jammu and Srinagar offices of the J&K Board of Professional Entrance Examinations on all days (including holidays) from 10 A.M. to 4 P.M. from 08<sup>th</sup> to 22<sup>nd</sup> of January, 2014. The Candidates who fail to deposit their Confirmation Page of Application Form complete in all respects by 25<sup>th</sup> of January, 2014 up to 4:00 P.M. shall have to pay a late fee of Rs. 1000/- (Rupees one thousand only) through non-refundable bank draft drawn in favour of the FA/CAO, BOPEE payable at Jammu/ Srinagar or Customised Bank Challan of transfer of the said amount in the BOPEE's HDFC Bank Account No 50100006864332 specified on the Bank Challan on or before

29<sup>th</sup> of January, 2014 upto 04:00 P.M. where after no Confirmation Page of online application form will be accepted whether submitted by hand or by post.

Application Forms (Confirmation Page) of all in service doctors must be routed through concerned Director, Health Services Jammu/Srinagar, otherwise their Application Forms shall not be entertained

**Eligibility conditions for appearing in the Entrance Test:**

A candidate must:

- (a) be a permanent resident of the J&K State.
- (b) possess MBBS/BDS Degree or its equivalent Degree recognised by the University of Kashmir/Jammu and the Medical Council of India/Dental Council of India;
- (c) be registered with the MCI/DCI/State Medical Council/ State Dental Council;
- (d) have completed satisfactorily one year pre-registration compulsory rotatory internship in a duly recognised institution as laid down by the University of Jammu/Kashmir for registration as a Medical/Dental graduate.

**Candidates who are likely to complete their rotatory internship and registration from MCI/DCI/State Medical/Dental Council by or before his/her turn of first date of counselling can also apply to appear in entrance test. However, if any candidate does not submit certificate regarding his/her rotatory internship, registration from MCI/DCI/State Medical/Dental Council on or before the date of his/her first counselling, he/she will not be allowed to participate in the counselling.**

- (e) have a valid Category Certificate from the prescribed Competent Authority (in case of candidate seeking selection under any reserved category) as required under rules. The candidates who mention category but do not possess valid category certificate at the time of submission of form will be considered in open merit, if he/she is otherwise eligible.
- (f) Non permanent resident Doctors having MBBS degree from J&K State and whose parents are presently serving in J&K state are eligible to appear in PG Medical Entrance Test in terms of SRO 158 of 1995 as open merit candidates.
- (g) sports category candidates shall be considered as Open Merit candidates if their Sports Points are not received from the J&K Sports Council till February 03, 2014.
- (h) be eligible in terms of SRO 08 of 2005 (For those candidates only who have already done post-graduation or Diploma and want to undergo post-graduation in any other specialisation).

**Other conditions:**

- (a) **Candidates claiming marks under SRO 401 dated 19-12-2009 should submit Difficult Area Service Certificate from respective Director, Health Services, Jammu/ Srinagar.**
- (b) **Candidates of reserved categories shall be treated as one unit in terms of Rule 15 of Reservation Rules 2005 for purpose of allotment of streams/disciplines.**
- (c) **Candidates of the reserved categories who figure in open merit by virtue of their higher merit shall be allotted streams/disciplines in accordance with Rule 17 of the Reservation Rules, 2005.**
- (d) **The minimum qualifying marks in the Entrance Test for selection in the Postgraduate Degree and Diploma courses shall be:  
50% for open merit category and 40% for all other reserved categories**

NOTE:

1. *The candidates are hereby sternly warned not to resort to any unfair / fraudulent means or act of impersonation. In case a candidate is found taking recourse to such acts, criminal proceedings shall be launched against him/her, besides debarring him permanently from appearing in the entrance examinations. Moreover, disciplinary action shall be recommended against the candidates who are in Government service, if they indulge in such practice..*
2. *If at any stage it is found that a candidate has given false or incorrect information in respect of any eligibility condition, his/her candidature will be cancelled without any notice.*
3. **NO "UNDER PROCESS" CERTIFICATES WILL BE ENTERTAINED IN ANY CASE**
4. *Application Forms (Confirmation Page) of online forms received after the prescribed date through any mode including speed/ registered post, shall not be accepted. No Application Form will be accepted if sent through courier.*
5. *Incomplete application forms shall be summarily rejected.*
6. *No correspondence shall be accepted in case any application form is not entertained or is rejected for a valid reason.*
7. *Details regarding available seats in Medical colleges/Dental College, eligibility criteria, Entrance Test, documents to be submitted, photographs etc. have been provided in the Electronic Information Brochure on the website. The seats indicated in the Information Brochure are yet tentative and subject to the final approval from MCI/DCI/State Government as the case may be.*
