Experience - 20 years (post qualification) or more in senior position in a large Engineering Industry/ Power Utility preferably Power Generation in a professional environment, out of which minimum two (2) years' experience in working in the rank of General Manager or equivalent position and experience of managing Coal Handling Plant in a Power Station.

3. Executive Director - Projects & Planning

Further, the Officers of State / Central Govt. having required qualification with working experience of 20 years or more as well as experience of at least 3 years in any Central / State PSU in the relevant field are also eligible.

5. Dy. General Manager - HR&A

Qualification – Graduate in any discipline with MBA (HR) or PG Diploma / Degree (2 yrs. full time course) in Personnel Management & IR or MSW or DSW or MHRM from any recognized University or reputed Institute approved by AICTE/IIMs/XLRI/ IISWBM. Degree in Law is desirable.

Experience - **18 years** (post qualification) or more in managerial position in a large Engineering Industry/ Power Utility/Manufacturing Industry/Construction Company in a professional environment with experience in handling IR issues, Contractor workers, legal, HR issues etc.

The candidates from PSU(Central / State) must have working experience for at least 5 years in next below Grade/Scale of Pay i.e. Pay Band of Rs. 15600/- to Rs. 39100/- with Grade Pay of Rs. 7600/- or equivalent scale of pay and the candidates from the Private Sector must have working experience at senior level position at least for 5 years respectively out of 18 years in a Company having manpower of not less than 500.
