2. **PAY SCALE**: Rs. 15600-39100 + 5400 Grade Pay + NPA+ Allowances.

3. ESSENTIAL QUALIFICATIONS:-

- (i) M.B.B.S.
- (ii) Registered with the Punjab Medical Council or with any other duly constituted Medical Council in India;
- (iii) Knowledge of Punjabi Language of Matriculation Standard or its equivalent: Candidate who do not possess this qualification shall have to acquire this qualification within six months of their joining the service failing which their services shall be terminated.

(Relaxable for Sikh Migrants to the extent that they will have to acquire such qualification within two years after joining the service failing which their services shall liable to be terminated)

<u>Important Note</u>: The candidates MUST possess the requisite qualification mentioned at para 3 (i) and (ii) above on or before 10th February, 2014 (i.e. The Last date of Submission of Online Application Form.)

4. AGE

- (i) Candidates should not be below 18 years and above 38 years of age as on 01-01-2014.
- (ii) Upper age limit may be relaxed up to 45 years for all States/ Central Government employees.
- (iii) The Upper age limit is relaxed upto 43 years for Scheduled Castes and Backward Classes of Punjab.
- (iv) Ex-servicemen of Punjab Domicile shall be allowed to deduct the period of his service in the Armed Forces of Union from his actual age and if the resultant age does not exceed the maximum age limit prescribed for direct appointment to such a vacancy in the Service Rules concerned by more than three years, he shall be deemed to satisfy the condition regarding age limit.
- (v) Upper age limit is also relaxable upto 42 years for Widows, Divorcees and certain other Categories of Women.
- (vi) Upper age limit is also relaxed upto 48 years for Physically Handicapped of Punjab.

5. <u>COMPETITIVE EXAMINATION</u>

The Commission shall hold a Competitive Examination on 2nd March, 2014 (Sunday) (2:00 PM to 5:00 PM) details of which are available on the Commission's website.
