## **Advertisement for Recruitment in the post of Manager – A (Electrical) / Manager – B (Electrical)**

Applications are invited from Indian citizens for recruitment to the following post under Tripura State Electricity Corporation Limited as detailed below :

**1. Name of post : Manager – A (Electrical) / Manager – B (Electrical).**

**2. Scale of Pay :** Initially recruitment will be on purely temporary basis as **Management Trainee – A, on Fixed Pay remuneration of Rs.13,000/- and & Management Trainee – B, on Fixed Pay remuneration of Rs.8,800/-** for 1(one) year. After successful & satisfactory completion of the tenure of Management Trainee they may be regularized in the scale of Rs. 9570-30000/- PB-3, Grade Pay Rs.3500 on the post of **Manager – A (Electrical)** and Rs.5310-24000/- PB-2 Grade Pay Rs.2400/- on the post **Manager – B (Electrical)** respectively.
