4. Minimum Educational Qualification: - (a) For the post having GP Rs. 1800/- Pass in Matric or ITI or its equivalent. Note: Candidates who apply for posts having Grade pay of Rs. 1800/- but have the educational qualification of only Class- VIII th pass can also be considered for appointment in (-) 1Spay Band (Rs. 4,440-7,440/-) without any Grade Pay provided they possess the Sports Qualification Such Sportspersons will be given to regular Pay Band PB-1 of Rs. 5200-20200/- along with GP Rs. 1800/- only on acquiring the minimum educational qualification under the recruitment rules or on passing the requisite training test.

5. (a) Age limit : Minimum 18 years - maximum 25 years as on 01.01.2014. (No relaxation in lower upper age limit is permissible for any category of candidates). (b) Proof of age: The date of birth as recorded in the Matriculation passed Certificate OR in a Certificate recognized as equivalent to Matriculation.

6. Period of Reckoning Sports Achievements: - Sports achievements within the immediate previous two financial years (i.e. on or after 01.04.2011 and current financial year (i.e. 2013-14) shall only be considered for appointment. For this purpose concluding day of the Championship shall be taken in considered, falling which the application will be rejected. Activeness in sports shall be adjudged as per the candidates' performance during the field trial.

7. Procedure for Recruitment: - Conduct of trial: I) Distribution of marks awarded by trial committee: trial of Candidates shall be conducted to assess their sports performance / suitability for the team of S.E.Railway. Candidates found fit in the trial will be considered for next stage selection.

The following is the format of marks for trial

i)	For Game Skill , Physical fitness & Coach's observation during trial	40 marks
ii)	Fit Candidate	Candidates securing 25 marks or more
iii)	Not fit candidate	Securing marks below 25 marks

II) After trial only the candidates declared the fit shall be considered for next stage i.e. interview / Documents verification no marks shall be given to candidate declared unfit in the trial for their sports achievement etc. only such candidates who are declared fit in trial and attend interview shall be awarded marks for sports achievements, educational qualification, general intelligence etc. No communication shall be entertained from the candidates in this regard. Please note that candidate’s entry in each stage of recruitment process shall be purely provisional

Qualification marks: minimum qualification marks for the recruitment through open advertisement is 60 marks.

Note: The offer of appointment shall be given purely on the basis of merit. In case more than one sports person scores the same marks, preference shall be given to the younger to decide the merit.

Date & venue & Time for trial will be intimated to eligible candidate through ordinary post. The venue for trial fixed by division will be binding and final. No request shall be entertained the decision of the division in all matters relative to eligibility acceptance or rejection will be final and binding on the candidates.

No correspondence shall be entertained in respect of any application which has been rejected similarly no intimation shall be sent to any applicant who is not called for trial / interview as well as found not fit after the trial / interview . Mere calling for trial does not confer any right or claim for appointment

8. Examination Fee: i) A Non refundable Bank Draft / IPO for Rs. 100 will be examination fee for UR & OBC candidates and it should be issued in favour of the addressee as indicate in the table para 10. SC ST Minorities economically backwards class are exempted from fees. Minorities will mean Muslims, Christians, Sikhs, Buddhists, Parsis. For claiming waiver of examination fee, application form, Economically Backward classes will mean the candidates whose family income is less than Rs. 50,000/- per annum, income certificate for this purpose should be issued from the specified Authority and on Specified Format as per Annexure-II.

9. How to Apply :- a) Application as per format given should be submitted on A4 size paper duly filled in by the candidates own handwriting, duly accompanying with attested copies of all certificates, Age proof certificate. Educational qualification and caste certificate should be self-attested by the candidate and should be enclosed along with application form. Any discrepancy found in the application and documents submitted by the applicant will render the application invalid. Candidates should write the “name of the event, category applied for and post applied for” in block letters at the top envelop which should be super scribed: “Application for recruitment against sports Quota 2013-14”. In case of serving employee “No objection certificate” from the employer should be attached. (v) Application without Signature or Signature in Capital letter. vi) Photo copies of documents not self attested by the candidate. vii) Without photo or affixing / attaching photo state copy of photograph. (viii) Without Demand Draft/ IPO of requisite amount and validity. (ix) Application not filled in English or Hindi or not filled by the candidate in his own hand writing. (x) Application without Date and legible (not blurred or smudged) thumb impression. (xi) Any other irregularity / incomplete application noticed and considered invalid by this Railway.

12. Other relevant instructions: Kindly ensure to (i) bring original documents in support of date of birth, educational qualification, sports achievements on the date of trial and interview: without which, you will not be allowed to appear in the selection trial. (ii) No TA/DA/ Accommodation will be given for appearing in the selection trial/ interview.
