Any applications received beyond the deadline will be summarily rejected.
2. All the eligible candidates should report in the office of CMO's Cantonment General Hospital, Sadar Bazar, Delhi Cantt at 9 AM on the day on interview with their application and their original certificates with attested copies in the format given below along with two self-attested photographs.
3. If the number of candidates is excessive, a written screening test may be held before the interviews or interviews may be extended/ scheduled for subsequent days. In such a case, necessary information will be displayed in the notice board on the date of the interview.
4. Original documents should be shown at the time of interview.
5. No TA/DA will be given for appearing in the interview.
6. The list of selected candidates will be displayed on the Main Notice Board of the hospital. No correspondence/personal enquired shall be entertained.
7. Jurisdiction: In case of any legal dispute the jurisdiction of court will be Delhi/New Delhi.
8. Number of posts may increase or decrease as per actual requirement.
9. The engagement may be terminated any time by giving one week's notice.
10. The selected candidate will be required to join duty within seven days of the declaration of the result which will be displayed on the hospital notice board.
