

IMPORTANT INSTRUCTIONS

- 1. The posts are to be filled up on contract basis/deputation initially for a period of 3 years.
- 2. The applicant who have applied against earlier advertisement No. 18/2013, 19/2013 and 20/2013 may apply afresh but they need not to pay application fee again. However, they are required to indicate advertisement no. and demand draft details.
- 3. Against the posts of Project Engineer, Executive Engineer, Hindi Officer, retired persons may also apply.
- 4. Mere fulfilling of qualifications and experience requirement would not entail a candidate to be called for selection process. No correspondence will be entertained from the applicant either before or after the selection. The decision of the Institute would be final.
- 5. Incomplete applications received without scanned photograph, signature, certified scanned copies of educational qualifications, experience etc. will summarily be rejected without any communication to the candidate. No further correspondence will be entertained in this regard.
- 6. NIFT will not be responsible for any postal delay / loss in transit in submission of documents within specified time.
- 7. Wrong declarations/submissions of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage.
