D or with published work of high quality in Political Science, Sociology, Public Administration, Constitutional Law or Ambedkar Studies actively engaged in research with 10 years experience in Post Graduate teaching and / or experience in Research at the University/National Level Institution, including experience of guiding Research at Doctoral level.

- (b) An outstanding scholar with established reputation who has made significant contribution to knowledge on one of the above areas.
- (c) The applicant should possess adequate knowledge and working experience on Dr. Ambedkar's thoughts and works and proved commitment to the cause of Social Justice / Human Rights including emancipation of Dalits, Backward caste / Classes, Women and Minorities.

General Conditions

The post carries allowances such as DA, HRA, etc. as per rules of the Institute, which at present correspond to those admissible to the Central Government Employees.

Qualifications and age can be relaxed in the case of exceptionally well qualified candidates. The Institute may also consider suitable candidates who might not have applied.
