The Registrar of the Institute is the custodian of records, the common seal and funds of the Institute and such other property of the Institute as the Board shall commit to his charge. He is required to provide administrative support to the Director and may be called upon to take up any other duties assigned by the Director or the Board of Governors. The Registrar shall also exercise such other powers and perform such other duties as may be assigned to him by the NIFFT Act or the statues or by the Director.

General Conditions for the post of Registrar:

- i. The applicant should not be more than 55 years of age.
- ii. The appointment will be on Deputation/Contract Basis for five years or till the age of 60 years, whichever is earlier.
- iii. The appointment can be renewed for another term.
- iv. Besides, pay and allowances, leave, medical facilities, etc. are admissible as per Rules.
- v. The prescribed qualifications are minimum and the mere fact that a candidate possesses the same will not entitle him/her to be called for interview.
- vi. The Institute reserves the right to restrict the number of candidates for interview to a reasonable limit, on the basis of qualifications and experience, higher than those prescribed in this advertisement.
