Online applications are invited by J.C.E.C.E. Board, from those candidates who fulfill the following eligibility criteria for admission to academic session 2014 – 15 in B.Tech, B. Sc. Agriculture, B. Sc. Forestry, BHMS courses :-

EDUCATIONAL CRITERIA

- Engineering - The candidate must have passed 10+2 examination with Physics and Mathematics as compulsory subjects along with Chemistry subject AND has obtained at least 45% marks (40% in case of candidate belonging to reserved category) in the above subjects taken together.
- B.Sc. Agriculture & Forestry – The candidate must have passed I.Sc. / 10+2 with Physics, Chemistry along with Mathematics or Biology.
- BHMS - The candidate must have passed I.Sc. / 10+2 with Physics, Chemistry along with Biology.

RESIDENTIAL CRITERIA

The applicant must be a citizen of India and local/Permanent resident of Jharkhand as per criteria laid down in the Memo No. 5/vividh – 09/2001(Domicile) Ka. 2695/Ranchi dated 29/4/02 of “Personnel, Administrative Reforms and Rajbhasa Department”, Govt. of Jharkhand.

AGE LIMIT

- Engineering – No age bar
- B.Sc. Agriculture & Forestry – minimum 17 years and maximum 22 years as on 1st July

2014. (3 years upper age limit relaxation has been allowed for SC/ST candidate)

RESERVATION CRITERIA

Reservation policy of Govt. of Jharkhand will be followed in the admission of all courses of Govt. and Non-Govt. Institutes.
