

Citi4Champ Contest Details

- 1. This contest is valid for residents of India aged 18 or above who have participated in the 'Citi48Champ' onground event held at select corporate parks in Chennai and Bangalore.
- 2. The Facebook contest starts on 11th April and ends on 13th April
 - Entry to the digital Facebook contest is only through the on-ground event. All those who participate in the on-ground event and give their consent for their picture to be uploaded on Facebook, will automatically be signed up for the digital Facebook contest with his picture uploaded to a photo album on the a newly created event page on Facebook The objective is to get maximum likes on the photo of the participant uploaded on Facebook. Each participant gets a head start with a score that he garnered during the on ground event. The participant has to mobilize his Facebook friendship to get likes on his photo uploaded on our FB page.
