



## **TERMS AND CONDITIONS OF FLASH INDIA GOLD COMPETITION**

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE SUBSCRIBING TO AND PARTICIPATING IN THIS COMPETITION KNOWN AS “**FLASH INDIA GOLD COMPETITION**”. BY PROCEEDING WITH SUBSCRIPTION TO THE **FLASH INDIA GOLD COMPETITION**, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS (“**Terms And Conditions**”). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE **FLASH INDIA GOLD COMPETITION**. **PARTICIPATION IN THIS COMPETITION IS PURELY VOLUNTARY.**

### **TERMS:**

This **FLASH INDIA GOLD COMPETITION** (hereinafter referred to as the “**Competition**”) is an optional Competition, conceptualized, hosted, organized and conducted by Celltick Mobile Media(India) Private Limited, a company incorporated under the Companies Act, 1956 and having its registered office at, 111/A Wing, Everest Grande, Opp Ahura Centre, Mahakali Caves Road, Andheri-East, Mumbai -400 093 (hereinafter referred to as “**Celltick**” or “**Organizer**”), for enabling active subscribers, who use the Vodafone India Subscriber Identity Module (“**SIM**”) on a regular basis for purposes other than to participate in the competition, pre-paid or post-paid category of Subscribers who are the rightful user of the Vodafone connection, in whose name the mobile phone connection number (MSISDN) is registered with the Vodafone India (hereinafter “**Subscribers**”) as specified in circles stated in Clause 2 herein, of either Vodafone India Limited, Vodafone Mobile Services Limited, Vodafone West Limited, Vodafone East Limited, Vodafone South Limited, Vodafone Digilink Limited, Vodafone Cellular Limited and Vodafone Spacetel Limited (hereinafter collectively referred to as “**Vodafone India**”) to participate in the Competition. In the event the number / connection is registered in the name of a company/ firm, the employee who is authorized to use the connection shall submit a No Objection Certificate (NoC) and authorization of the employer duly permitting the employee to use the number for participation in the Competition, receive the prizes and accept the terms applicable for the Competition. The Competition is open to Subscribers during the period from **19-01-2015** from **00:00:01 hrs to 02-02-2015 till 23:59:59 hrs**, (hereinafter referred to as the “**Competition Period**”). Organizer reserves the right to extend or shorten the Competition Period, as it deems fit from time to time without any prior intimation to the Subscriber/s or any interested party.

1. This is a Pay Per Use (“PPU”) product and broadcast will be sent on a daily basis.
2. The Competition is open for all participants who satisfy the eligibility criteria mentioned below and who belong to the following Vodafone India telecom circles (“**Circle(s)**”) of ANDHRA PRADESH, ASSAM, NORTH EAST, BIHAR, DELHI, GUJARAT, HARYANA, JAMMU AND KASHMIR, KARNATAKA, KERALA, KOLKATA, MAHARASTRA, MADHYA PRADESH, MUMBAI, ORISSA, PUNJAB, RAJASTHAN, UTTAR PRADESH EAST, UTTAR PRADESH WEST, WEST BENGAL, TAMIL NADU and CHENNAI. This competition will not be applicable for participants in Himachal Pradesh.
3. A participant by participating in the Competition, hereby agrees to the Terms and Conditions mentioned herein and gives his/her irrevocable consent to the Terms and Conditions including to



the procedure for Winner selection of the Competition as set out herein, and any appropriate changes that may be made to this Competition by the Organizer or Vodafone India including due to any legal or regulatory requirement, instructions from any judicial or a quasi-judicial body or due to any natural calamity beyond the reasonable control of Vodafone India or Celltick, their affiliates and associates or for any reason whatsoever.

4. For the purposes of these Terms and Conditions, wherever the context so requires “**You**” or “**Your**” shall mean any natural person who is a participant.
5. Also, by participating in this Competition, You:
  - Warrant that prior to participating in the Competition, it shall be deemed that You have read, understood and have agreed to be bound by the Terms and Conditions herein.
  - Warrant the accuracy, truthfulness and currency of all information that You may have submitted;
  - Agree that You are entering into this Competition as an independent party and nothing herein establishes an employer-employee relationship between You and Vodafone India or between You and Celltick and You are acting voluntarily, using Your own time and resources to participate in the Competition, solely at Your own risk; and
6. Participation in the Competition will be construed as an acknowledgement and acceptance of the Terms and Conditions set out herein and those mentioned on the Customer Application Form.
7. Subscribers who are roaming outside their home circle will also be entitled for participating in the Competition, except if Subscriber is roaming in Himachal Pradesh as the service is not live in that circle. In such a scenario the Subscriber will be able to participate in the Competition only when he is back in the eligible circles.
8. These Terms and Conditions are available on the Website of the Organizer at the following address: [www.celltick.com/flashindiagoldcompetition](http://www.celltick.com/flashindiagoldcompetition) (“**Website**”). The Terms and Conditions can be amended or varied from time to time or withdrawn without any prior notice and therefore, please visit the Website regularly to keep Yourself updated and informed. If any Subscriber at any point of time during continuance of this Competition does not agree to any of the Terms and Conditions, such Subscriber shall immediately cease to participate in the Competition.

#### **9. Procedure and Eligibility to participate in the Competition**

This Competition is valid for participants who fulfill the following criteria:

- He/she must be of at least 18 years of age;
- He/she must be a resident of India;
- He/she must be an existing active user of Vodafone India;
- He/she must belong to any one of the eligible Circles mentioned in Clause 2 above;
- He/she must not be of an unsound mind; and
- He/she must not be under any legal disability e.g. insolvency, restraint by court order etc. and / or is prohibited from entering any contractual relationship.



Further, the participants who participate in the Competition and are chosen as Winners of each category of prize in accordance with the Winner selection process under the Terms and Conditions of the Competition shall be required to be the registered Vodafone India Subscribers of the winning mobile phone number and not merely the participant using such mobile number (“**Winner**”). If the Winner is not able to provide sufficient evidence to show that he/she is the Subscriber of the mobile number, the Organizer reserves the right to award the prize to the next eligible Winner or to forfeit the prize, at its sole discretion.

If, in any State and/or territory or part thereof, the running of this Contest is prohibited as per local rules or laws, the Subscribers from such State and/or territory or part thereof shall not be eligible to participate in the Contest. No further notice shall be given by the Organizer or Vodafone India, in this regard.

#### **10. To participate in the Competition:**

The Competition is valid for all active Vodafone India Subscribers who could either be a prepaid or postpaid user. Any active Subscriber playing this Competition shall be referred to as a “**Participant**”, throughout these Terms and Conditions.

- To participate in the Competition, Subscribers need to just participate in the Competition from their home screen (through Flash broadcasts (on Active Flash enabled SIMs).
- Participants can also participate in the competition by sending SMS “flash indgold” for Competition activation to short code 12320.
- There is no additional amount charged while activating Vodafone Flash.
- Competition will be available via broadcasts on all Active Flash enabled SIMs.
- Participants can participate in the Competition by answering questions @Rs. 5 per question.
- Each correct answer is worth 1 point.
- Prizes will be for daily, weekly and monthly Winners.
- **There are 2 grant prizes whereby top 2 Participants who have accumulated highest points for the 15 days will stand a chance to win the grant prizes (details mentioned below in the grid).**
- Before the launch of every competition all the existing participants will be sent promotional broadcasts, informing them of the upcoming competition, the prizes and its charges.
- Users without Vodafone Flash SIMs can upgrade their SIMs to Vodafone Flash enabled SIMs from any of the Vodafone stores to participate the Competition.

#### **11. Competition Flow**

- Competition will be open in **all the above mentioned circles** of Vodafone India as stated in Clause 2 herein above.
- All Vodafone active users can participate in this Competition via broadcasts.
- Users will receive several broadcasts a day, promoting a competition that will entitle the maximum point Winner to a defined prize.
- As users start answering the questions, they would be presented with more and more questions and opportunities to answer them for gaining more points and increasing the possibility of winning.
- On answering each question the user will be informed about his current score followed by the next question.



- On answering the questions the participants will be charged Rs. 5/- per question answered through broadcasts.
- Participants will score one point for every right answer. There will be no negative marking for wrong answers.
- The questions have 3 answer options each.
- The score counter will be set to ZERO at the beginning of the Competition and then again back to Zero at the end of the Competition Period.
- In case the Participant stops participating in the Competition and if he comes back to participate in the Competition after a gap of days, then he starts back with the last accumulated points at what he stopped participating in the Competition.

## **12. Charging:**

Subscriber can start participating in the Competition anytime during the validity of the Competition; the Subscriber will be charged Rs. 5/- per question answered in the Competition. In case if the participant does not wish to participate in the Competition then all he needs to do is not answer the questions.

## **13. Competition Promotion**

- Through broadcasts – Active Vodafone Flash enabled users will receive periodic broadcasts in a day.
- Non-Flash users will have to acquire a Vodafone Flash enabled SIM from the Vodafone Store.
- Competition will be available in English on Cell broadcast/SMS.

## **14. Competition Period**

The Competition starts on the proposed date 19-01-2015 at 00:00:01 hours and closes on last day of 02-02-2015 at 23:59:59 hours (“**Competition Period**”) and during this Competition Period it is open for both prepaid and post-paid Subscribers. (The duration and start/end dates will depend on the theme and will be mutually decided between Vodafone India and Celltick).

## **15. Selection of successful Winners –**

The prizes that Winner participant of the Competition wins is purely owing to his/her participation to the Competition and based on the performance and meeting of the selection criteria of Competition, as laid out in the Terms and Conditions. These prizes to the winning participant shall be distributed by Celltick through any means, and at any time, upon such terms and conditions as it may deem fit.

The selection process of the successful Winners for the prizes in this Competition will be as follows:

The selection for the Winner will be conducted after the end of Competition Period (except for the daily Winners who would be short listed on a daily basis). The selection of the Winners will be done purely on the basis of the logs and data containing time, duration and the number of answers given by each Participant and total points accumulated by the Participants as verified



and certified by the independent auditor appointed by the Organiser. The MSISDN with the highest scores basis the logs and data verified by independent auditor will be the Winner. In case of a tie, the Participant who has reached the score earlier basis the time stamp will be chosen as the Winner.

**Daily Winners Selection** – The Winners for these will be selected on the basis of the highest cumulative points achieved for the particular day across all Vodafone circles, 4 Winners will be selected with the highest cumulative points achieved across all Vodafone circles each day for 15 days, Daily Winners gratification will be disbursed post 3 days of the winning date by the Organiser. In case of a daily Winner, Winner will be shortlisted the next day post which Celltick will share the MSISDN to Vodafone who will confirm the Winner details. On getting confirmation from Vodafone, Celltick will forward the daily recharge to the Winner. The daily Winners will be selected each day basis the highest cumulative points achieved on a pan India Level across all circles, Rs.2000/- recharge for four top scorers of the day, total of 60 Winners for 15 days of the competition (Total: Rs.120000/-), In case if the customer is a postpaid Subscriber then we shall credit his/her postpaid account with Rs.2000/-.

**Weekly Winner Selection** – The Winner for these will be selected on the basis of the highest cumulative points achieved for the week for a customer across all Vodafone circles. Weekly prizes will be given post end of the competition period. Each week there will be 2 prizes selected whereby 2 customers will be selected every week basis the highest cumulative points achieved for the week on a pan India basis across all circles, 2 Winners each for every week, total of 4 Winners, each Winner gets Gold Voucher worth Rs.6600/- (Total Rs.26400/-).

**Grant Prize Selection** - The Winners for this will be selected on the basis of the highest cumulative points achieved for 15 days for Participants across all Vodafone circles. Grant prizes will be given post end of the competition period. There will be two grant prize Winners which will be selected on the basis of highest cumulative points and second highest cumulative points over a period of the competition period. Total of 2 Winners, each Winner gets Gold Voucher worth Rs.66000/- (Total Rs.1,32,000/-). TDS/Taxes as applicable on the said Grant Prize will be borne by the Organizer.

In case of a tie, the Winner with highest cumulative points in the least amount of time on the basis of the data and log timings as verified by the independent auditor shall be selected as the final Winner. In case the Winners are still on tie then we shall provide both the Winners with the actual prize (which means that we shall give away same prize to both the Winners).

**A participant is eligible to win any number of prizes. He/She should fall into the criteria of selection basis his achievements. There is no restriction on their winning any number of prizes as long as their achievements are on basis of the selection criteria.**

16. The prize(s) under the Competition are neither assignable nor transferable under any circumstances. All the prizes under the Competition shall be subject to the Subscriber complying with such Terms and Conditions as may be applicable and duly complied with by the Winners of the Competition.
17. If any part of these terms and conditions of use are determined by a court of competent jurisdiction to be invalid or unenforceable, that part shall be limited or eliminated to the minimum extent necessary so that the remainder of these terms and conditions are fully enforceable and legally binding.
18. The list of Winners of all prizes will be announced by the Organizer after the end of the Competition and/or after the Winner selection process is completed.
19. All prizes will be given after deducting various taxes, license fees and charges as applicable, except as otherwise stated in writing.
20. The Winner shall not be entitled to the prize, in case he/ she fails to clear all outstanding dues payable to Vodafone India and / or is not an active Subscriber of Vodafone India on the date of claiming the prize.
21. To be eligible to claim the prizes of the Competition, the winning MSISDNs have to be active Subscribers of Vodafone India at the time of the Winner announcement.



22. The verification of the independent auditor as appointed by the Organizer in respect of all transactions under this Competition, including without limitation the selection of Winners and other related transactions shall be final and binding and no complaints, claims, correspondence or communication shall be entertained in this regard.
23. All prizes offered in this Competition will be sponsored and distributed by Celltick or a designated third party.
24. All prizes offered in this Competition are subject to availability. The Organizer shall not entertain any requests for any particular model, color, variant or design of the prizes offered under this Competition. Organizer reserves the right to provide alternate prizes for any of the prizes of the same value without prior intimation or consent of the Subscribers to the Competition.
25. After the selection and validation by the independent auditor of the Winners of all the prizes under the Competition, the Winners will be contacted, by calling them on 3 consecutive days on the number of the Winner registered with Vodafone India, and will be given further details as to how, when and where they can collect their respective prizes. **Also the Winner needs to submit their respective documents within 7 days from the date of confirmation by the organisers.** In the event the Winners do not answer the calls of the Organizer, an SMS will be sent to the MSISDN of the Winners intimating them regarding their winnings and providing them the details as to how, when and where they can collect their respective prizes (“Intimation”). Post sending the SMS the customer needs to be responding the same day or the next day. The prizes must be claimed by the Winners within 15 days from the date of Intimation to the Winner, failing which, the prize(s) will be deemed to be forfeited by the Organizer(s) under the respective categories under the Competition. The Prizes offered under the Competition may be given to the Winners during a special event, the venue, date and time of which shall be announced by the Organizer, at its sole discretion, subsequent to completion of the Competition. In the event no special event is being conducted by the Organizer, the Winners shall be requested to provide their address to which the prizes may be sent by Organizer, by calling the number provided in the SMS within 7 days from the date of sending the SMS, failing which the prize shall be forfeited. The prizes shall, under no circumstance be distributed from the amount charged by Celltick or Vodafone India for participating in the Competition. Delivery of prizes will be subject to the Winners giving the correct address and his/her availability there. The Winners agree that there shall be no liability on Organizer or Vodafone India in the event such message does not reach such Winner on any account for any reason whatsoever. In the event that any of the Winners cannot be reached over phone or through SMS for a period of 3 days from the date of Intimation or are ineligible or are disqualified, for any reason whatsoever, the Organizer reserves the right to forfeit the prize at its sole discretion.
26. Without prejudice to the foregoing Clause 24, any failure on the part of the Winners of the Competition to comply with directions issued by the Organizer or Vodafone India shall entitle the Organizer or Vodafone India at their discretion, to cancel and forfeit the prize for the said Winner and/or the same prize will be given to the next eligible Winner. All costs and expenses for collecting the prize unless otherwise specified shall be borne solely by the Winners and the prize shall not be transferable and no request shall be entertained by the Organizer or Vodafone India for such transfer. In the event the prizes cannot be delivered, when specified that they will be delivered, due to reasons beyond the control of the Organizer, the Winners shall collect them from the place specified by the Organizer.



- 27.** These Terms and Conditions are subject to guidelines/directions issued by the Department of Telecommunications (“DoT”), Telecom Regulatory Authority of India (“TRAI”) or any other statutory authority from time to time.
- 28.** Neither Vodafone India nor Celltick shall be responsible for any claims arising out of technical failures before, during, between or after the completion of this Competition, including but not limited to any technical failures in the telephone lines, mobile connectivity, any action that has been initiated, actioned or completed through the Subscribers mobile phone, failure of servers or the failure to provide the correct Competition score updates or any mistakes arising out of technical snags or resultant inability of the listener for participation. Further, neither Vodafone India nor the Organizer shall be responsible for any claims arising out of any failure(s) which is beyond the control of the Organizer or Vodafone India.
- 29.** The Subscribers hereby agree and undertake not to hold the Organizer, Vodafone India and/or any of their group entities or affiliates, their respective directors, officers, employees, agents, vendors, responsible for or liable for, any actions, claims, demands, losses, damages, costs, charges and expenses, either direct or remote that they may/might have suffered, sustained or incurred, or claim to suffer, sustain or incur, by way of and /or on account of their subscription to the Competition or participation in it.
- 30.** Organizer, Vodafone India and their affiliates shall be entitled to use, in any manner, the details of the Subscribers, including the Information i.e. name, photograph etc. for their sales, marketing and promotional purposes, including the prizes awarded to them, if any. By participating in the Competition, all participants hereby agree to the same. Organizer and Vodafone India may, at their discretion, choose not to disclose the identity of the selected Subscribers to other Subscribers except as expressly mentioned in the Terms and Conditions herein.
- 31.** Prize(s) shall neither be transferable nor exchangeable for cash, unless otherwise expressly agreed by the Organiser. Mere participation in the Competition shall not entitle a Subscriber to the prize. No other person or agent can claim the prize on behalf of the Subscriber.
- 32.** A Subscriber shall be considered ineligible if he/she does not conform to the conditions as stipulated in these Terms and Conditions, or cannot provide any of the required documents as stipulated in clause 32 herein.
- 33.** All prizes must be claimed by the Winners, along with the documents specified herein below within the time period specified by the Organizer and Vodafone India. The documents required to be submitted along with the claim by the Winners include the following (the document list is only inclusive and not exhaustive and can change as per the requirements of law):

  - a. Identity Proof;
  - b. Address Proof;
  - c. Photocopy of PAN Card;
  - d. In case of Winner holding a post-paid connection of Vodafone India number and is entitled to a prize, the value of which exceeds [Rs. 5,000/-], self-attested copy of the latest bill issued by the operator in respect of the Vodafone India number registered with the Organizer under the Competition;





- e. In case of Winner holding a pre-paid connection of Vodafone India number and is entitled to a prize, the value of which exceeds [Rs. 5,000/-], an affidavit in the format provided by the Organizer, declaring that the Winner is the rightful user of the Vodafone India number and the same is registered with the operator in the name of the Winner;
- f. Letter of Compliance with rules and regulations and declarations in the format as may be required by Vodafone India or applicable law.
- g. Any prize of value in excess of INR 10,000/- in a year\*\*\* will attract deduction of tax at source and all taxes to be paid on the prize/s shall be paid by the Organizer at the prevailing rate. Further, all the Winners must furnish a valid Indian PAN Card to claim the prize amount, or prize, irrespective of the value of the same, failing which the Winners' prize shall be forfeited, or the prize shall be rolled over to the next eligible Winner, at the sole discretion of the Organizer(s).
- h. In case of the winning MSISDN being registered on a name of any form of organization, the player needs to submit a letter of consent duly signed (on the organization's letter head) from the organization stating that the MSISDN is allocated to the player. The letter should state the player's full name, address and pan card details, failing which the Winners' prize shall be forfeited, or the prize shall be rolled over to the next eligible Winner, at the sole discretion of the Organizer(s).

\*\*\*A Subscriber earning prize in excess of INR 10,000 in a year in aggregate from all competitions or offers conducted by Celltick Global Limited as one of the Organizers irrespective of the Operator or other Organizers will be subject to TDS under the Income Tax Act, 1961, if applicable.

- 34.** Organizer and Vodafone India are not liable for any direct or indirect costs or expenses in relation to the Competition which are to be borne by the Subscriber personally, including without any limitation such applicable taxes as required to be borne by the Subscribers eligible for the prize.
- 35.** In all Vodafone Competitions held in the financial year 2013-14, if one individual Winner, irrespective of number of mobile connections registered in his/her name with Vodafone India, has already won prizes aggregating Rupees Ten Lakhs or more for such financial year 2013-14, he/she will be eligible to win prizes worth up to Rupees Ten Thousand only, for the financial year 2014-15.
- 36.** This Competition contains factual references to the names of certain companies, products and individuals. The Organizer makes no representation of having a business relationship or tie up with any such companies, products or individuals. All trade names shall continue to remain owned by their respective owners.
- 37.** By participating in the Competition, You confirm and waive the applicability of rules and regulations of the National Do Not Call Registry and You agree to receive promotional messages and alerts including without limitation daily updates on the score under the current Competition and updates about current and upcoming competitions from the Organizer, as it may in its sole and absolute discretion decide.



- 38.** Any Subscriber providing any incorrect information or concealing and/or withholding any information from the Organizer or from Vodafone India with intent to participate and/or win any prize/s in this Competition will automatically be disqualified from participating in it and winning the different categories of prizes under the Competition. Such act of providing incorrect information or concealing and/or withholding any information, including without limitation incorrect declaration of information relating to name, age, identity, address, mobile connection of Vodafone India number, domicile, payment of outstanding amount to Vodafone India or any other information provided by the Subscriber, shall entitle the Organizer to disqualify him/her without any further intimation. If the Subscriber has collected the prize based on such incorrect information and the error in his information is detected subsequently, the Organizer shall have the full right and authority to pursue legal action against such Subscriber to recover the prize wrongfully collected by such Subscriber.
- 39.** The Subscriber shall not have the right to claim any damages, loss or costs from the Organizer and Vodafone India for delay in delivery of the prize(s) on any grounds whatsoever.
- 40.** Organizer and Vodafone India are not liable for any loss or damage of any nature whatsoever if incurred in connection with the Competition.
- 41.** This Competition shall be governed by the laws of India. Any dispute arising out of this competition will be referred to a Sole Arbitrator to be appointed by Vodafone India, whose decision shall be final and binding on the parties. The place of Arbitration shall be at Mumbai.
- 42.** The prize(s) to the Winners shall be given subject to compliance with all applicable statutory legislations, processes and formalities in connection with the prize(s) and on production of all such documents or papers as may be required by the organizer before accepting the delivery of the prize. The Winners will have to bear their own cost of travel and lodging and boarding, if required, to collect their prizes.
- 43.** The Organizer, at its sole discretion, may or may not provide a cash alternative to any of the prizes being offered in this Competition.
- 44.** All costs or levies any other taxes applicable as levied by the Central, State or Municipal government or any other liabilities related to the prize(s), if any, shall be exclusively borne by the Winner, including but not limited to TDS, Gift tax (if any), Insurance and any other taxes applicable by the Central, State or Municipal government.
- 45.** The prizes shall be handed over by the Organizer on receipt of all the documents under Clause 32, from the Winners, required to process the distribution of the prize.
