#### ELIGIBILITY

**MBA :** Candidates applying for admission to the Two Year Full-Time MBA must hold a Bachelor's Degree in any discipline after 12 years of formal schooling with at least 50% marks (SC/ST:- Passing marks; OBC/PwD/CW:- 45%) or equivalent to CGPA, as per CAT 2013 advertisement requirement. Candidates appearing for the final year examination of Bachelor's Degree examination may also apply.

**DOCTORAL PROGRAMME:** Candidates, seeking admission to FMS Doctoral Programme are required to take the Common Admission Test (CAT) 2013 conducted by Indian Institutes of Management during October 16<sup>th</sup>, 2013 to November 11<sup>th</sup>, 2013, unless exempted as per stipulations in FMS information bulletin. Candidates exempted from the admission test are required to apply along with a demand draft of Rs. 250/- drawn in favor of "The Registrar, University of Delhi" by 13<sup>th</sup> January 2014. For application form and other eligibility conditions, please refer to the website of the University of Delhi ([www.du.ac.in](http://www.du.ac.in); Eligibility Criteria for Enrollment to Doctoral programme).

**FOREIGN STUDENTS:** All Foreign Nationals seeking admission to MBA and Ph.D. programmes should apply through the office of the Dy. Dean (Foreign Students) Conference Center, Opposite Botany Department, University of Delhi, Delhi-110007, India. Foreign nationals studying in Indian Universities are required to appear in the Common Admission Test (CAT) 2013, and foreign nationals with Indian degree (but not currently staying in India) are required to submit GMAT score (minimum score 650). However, foreign nationals with foreign degrees are required to submit both GMAT and TOEFL scores.

#### **ADMISSION PROCEDURE**

Applicants can register themselves for admission to M.B.A. (Full-Time) and Ph.D. programmes through FMS website [www.fms.edu](http://www.fms.edu) by filling up online registration forms and by paying the requisite fee of Rs.1000/- (Rs.350/- for SC/ST/Person With Disability category) for each programme, during 11<sup>th</sup> November, 2013 to 31<sup>st</sup> December, 2013. Admission to M.B.A. (Full-Time) programme will be based on Personal Interview, Group Discussion and CAT-2013 score (Common Admission Test conducted by Indian Institutes of Management during October 16<sup>th</sup>, 2013 to November 11<sup>th</sup>, 2013) while admission to Ph.D programme will be based on Personal Interview and CAT 2013 score, wherein applicable. Applicants may visit [www.cat2013iimdr.ac.in](http://www.cat2013iimdr.ac.in) for appearing in the Common Admission Test (CAT) 2013. Applicants who have not taken CAT-2013 will not be considered for admission. The details of Personal Interview based admission procedure / selection criteria for these programmes are available in the Information Bulletin of Faculty of Management Studies.

**Note :** (i) A candidate may apply for one or more programmes of FMS. (ii) Incomplete form(s) and those without requisite fee will not be entertained. (iii) FMS, University of Delhi will not be responsible for any postal delay. (iv) FMS will not entertain any chargeback cases of online payment. (v) All matters of dispute will be subject to the legal jurisdiction of Delhi only. (vi) Those applying for the reserved category seats (SC/ST/OBC/PwD/CW) need to send self-attested photocopy of their applicable category certificate. (vii) All candidates are required to send the computer generated registration form, after online registration, along with the supporting documents to FMS latest by 13<sup>th</sup> January 2014.(viii) FMS uses CAT score for shortlisting the candidates for the above programmes . IIMs have no role either in the selection process or in the conduct of the programme. (ix) The eligibility criteria for CAT is as set by the IIMs. (x) The candidates should follow the CAT advertisement of IIMs for procurement of CAT Vouchers through designated branches of bank(s) and other designated places as indicated in the CAT 2013 advertisement.
