#### Guidelines for Submissions

- All submissions must be in electronic medium.
- We only accept '.doc' or '.docx' file format.
- All submissions must be made via [www.lawfreaks.org/ksol-essay-submission](http://www.lawfreaks.org/ksol-essay-submission)
- File should be drafted in the following pattern:
  - Font Type: Times New Roman.
  - Spacing: 1.5 inch spacing.
  - Font Size: 12 points
- Length of the Essay should be within 5000 words (exclusive of end notes). Entries exceeding the word limit will be disqualified.
  - No 'foot notes' will be entertained; participants are required to provide 'end notes'.
- Plagiarism is strictly prohibited and can invite detrimental consequences.
- Submitted essays may be chosen for publication in KLS Journal at the sole discretion of the editorial board.
