

- *Note I :- Candidates selected against these categories (Ex-Serviceman, Physically Handicapped) will be adjusted in their respective community against the vacancies earmarked in OC, OBC and SC.
- *Note !! :- Only such persons would be eligible for applying in physically handicapped Quota who suffers from not less than 40% of relevant disability. The following disabilities are eligible for the said posts:-
 - OH (Orthopaedically Handicapped)
 - HH (Hearing Handicapped)
 - VH (Visually Handicapped---- Low Vision only)- "Person with low vision" means a person with impairment of visual functioning even after treatment or standard refractive correction but who uses or is potentially capable of using vision for the planning or execution of a task with appropriate assistive device.
- The vacancies notified are likely to vary/change without any prior intimation.
- 3. Pay scale: -₹ 5200-20200 (Pay Band-I) with Grade pay of ₹ 2,000/- and admissible allowances.

- Age limit: Between 18 and 27 years. The age limit is relaxable for candidates be 4. Scheduled Caste upto 5 years and for candidates belonging to Other Backward Castes upto bia Post years and for Government servants up to 40 years, for Ex- Servicemen and PH candidates in accordance with the instructions issued by the Central Government time to time.
- Note: The crucial date for determining the age limit shall in each case be the closing date i.e. 06.01.2014 for receipt of applications from candidates in India (and not the closing date prescribed for those in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh Division of Jammu and Kashmir State, Lahaul and Spiti District and Pangi Sub division of Chamba district of Himachal Pradesh, Andaman and Nicobar Islands and Lakshadweep).
- Educational Qualification: -5.

For Postman: - Matriculation from a recognized Board or University.

For Mail Guard :-

Matriculation from a recognized Board or University or equivalent.

- The candidates shall be subjected to an Pattern and Syllabus of Examination:-6. Aptitude Test of 100 marks of the level of 10th class/Matriculation covering the subjects/topics given below.
 - 25 questions on General Knowledge, Reasoning and 25 Marks Part 'A' -Analytical Ability- Multiple Choice Questions.
 - 25 Marks 25 questions of Mathematics- Multiple Choice Questions. Part 'B' -
 - 25 Marks 25 questions on English Language Objective Type/Multiple Part 'C' -Choice Questions.
 - 25 Marks 25 questions on Hindi language Objective Type/ Multiple Part 'D' -Choice Questions.
- **Duration of Examination:-**90 Minutes. 6.1

Qualifying Marks:-6.2

- Minimum 10 marks for OC, 8 Marks for SC and 9 Marks for OBC candidates in each (a) part.
- 40% marks for OC, 33% marks for SC and 37% marks for OBC candidates in (b) aggregate.
- Selection Procedure:- The selection will be purely on merit basis, which will be prepared on the basis of marks obtained in the Aptitude Test. It is further stated that:-
 - (a) If two or more candidates secure equal marks in Aptitude Test and they are standing in the last position in the merit list, then it is clearly stated that the candidate senior in Age will be considered for selection.
 - (b) If two or more candidates secure equal marks in Aptitude Test and they are standing in the last position in the merit list & their ages are also the same, then candidates who secured higher percentage in the 10th Class/matriculation will be considered for selection.
- Cost of Application:- The Application Forms shall be sold at a price of ₹ 100/- (Rs. One 8. Hundred only) and the sale will be through All Head Post Offices and identified Post Offices in the Circles. The sale will commence from 25.11.2013.
- Examination Fees:- The candidates have to pay the prescribed Examination fee of ₹ 200/- (Rs. Two Hundred only) and it should be deposited in any of the Post Offices of Haryana Circle and obtain ACG-67/UCR receipt. All female candidates and candidates belonging to scheduled caste/scheduled tribe and physically handicapped categories are exempted from payment of examination fee. No examination fee exemption is however available to OBC candidates and they are required to pay the examination fee in full. Applications received without prescribed fee receipt shall be summarily rejected.

Note I: Fees once paid shall not be refunded under any circumstances.

Note II: Fee paid through any mode other than UCR/ACG-67 in Post Office will not be accepted.

- The applications should be sent through Speed Post or Registered ndia Post **10**. Mode of Dispatch: Post only. Those received through courier, delivered in person or by any other means will not be accepted.
- The candidates are required to enclose attested copies of all supporting documents, two **11**. attested photos and self-addressed envelope with postage stamps of ₹ 40/- affixed on it (₹ 17/- in case of local candidates) as speed post charge along with the Applications. The envelope addressed to concerned Divisional Head must bear name of post for which the application is being sent in Bold Letter.
- **12**. Last Date of Receipt of Application: Last Date of receipt of applications by the Divisions is fixed as **06.01.2014** for normal areas and for those residing in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh Division of Jammu and Kashmir State, Lahaul and Spiti District and Pangi Sub division of Chamba district of Himachal Pradesh, Andaman and Nicobar Islands and Lakshadweep is 13.01.2014.

Disqualification:-**13**.

- Person who has entered into or contracted a marriage with a person having a spouse living; or
- Person who, having a spouse living, has entered into or contracted a marriage with any person,

shall not be eligible for appointment to the said posts provided that:-

The Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- Any person appointed to the said posts, shall be liable to serve in the Army Postal Services in 14. India or abroad as required.
- **15**. No TA/DA is admissible.

16. **How to Apply:-**

- (a) The application Form should be duly filled up in Hindi or English with all required information.
- (b) Incomplete or unsigned Application Form, Applications received without required certificate/photos, Applications wrongly addressed or received after due date will be rejected whatever may be the reason for delay. No intimation will be sent in this regard
- The application should be submitted in original form attached herewith. Any other form/photo copy of the form will be summarily rejected.
- (d) One envelope should contain application of one candidate only in respect of only one post.
- The envelope containing the application must be super scribed in bold letters as "APPLICATION FOR RECRUITMENT OF (Post for which applied).
- (d) Photo copies of all the required documents/certificates duly attested by gazetted officer should be sent alongwith the application. The documents should not be submitted in original. The documents/mark sheets/certificates submitted at a later date will not be entertained.
- (e) Photographs: Paste one passport size photograph on application at the prescribed space and get it attested from a gazetted officer and send another photo loose with address written on back side.
- **17**. The nature of work in the Railway Mail Services requires rotation of duties including night shift/detention on Overtime duty in the exigencies of service.
- 18. The Department has the right to cancel the recruitment process at any stage.
