West Bengal State Health & Family Welfare Samiti intends to engage on contract basis for the post of **Medical Officer (AYUSH)** under **Rashtriya Bal Swasthya Karyakram (RBSK)** of RCH, Department of Health and Family Welfare, Government of West Bengal.

**Eligible candidates should apply online in the prescribed format as given in the Department's website from 11 am of 16<sup>th</sup> December, 2013 to 5 pm of 6<sup>th</sup> January, 2014 for the mentioned post.**

**Only on-line Applications will be accepted. Application forms not properly filled in or incomplete Application forms are liable to be cancelled.**

## Details of the position

- Post** : **Medical Officer (AYUSH) (preferable 50% female)**
- No. Vacancy** : **964 (SC- 199 , ST- 82, OBC-A-88, OBC-B-62 , AND GENERAL- 524 : Reserved for Persons with Disabilities- 27)**  
**The vacancy is likely to increase marginally at the time of engagement.**
- Place of Posting** : **In any District of West Bengal**
- Essential Qualification** : **The candidate should have BHMS/BAMS/BUMS degree from any institution recognised by respective Councils of that stream. Must have completed compulsory internship at the time of submission of application.**  
**(In case of (BHMS):** The qualification shall be one included in the second Scheduled of Homoeopathic Central Council ACT 1973. Candidates must registered either in Part-A, of the State Register of Homoeopathic Medical Practitioners maintained by the Council of Homoeopathic Medicine, West Bengal or in Part 1" of the Central Register maintained by Central Council).  
**The candidate should be permanent resident of West Bengal and should be able to read, write and speak in Bengali.**  
**Persons holding MD in Homeopathy / Ayurvedic / Unani from any institution recognised by respective Councils of that stream, will be given additional marks.**
- Process of recruitment** : **Screening of applications, Merit list of eligible candidates based on scoring of academic qualification starting from Secondary onwards as stated in the Scale of Scoring in Annexure. Shortlisted candidates from the Merit List will be called for original testimonial verification. After successful verification of original testimonials, category wise final selection list according to merit will be prepared for appointment in any District of West Bengal.**
- Age limit as on 1.10.2013** : **Not exceeding 40 yrs (relaxation in age will be given for SC/ST/OBC candidates as per extant rule & order in this regard).**

**General Information for the Applicants/Candidates**

1. Only online Applications will be accepted. **Application forms not properly filled in or incomplete Application forms are liable to be cancelled.** If the online application details submitted by the applicant differ with the original testimonials, that application shall liable to be cancelled.
2. If proper signature and photograph of the applicant is not uploaded at the time of online application that application shall also liable to be cancelled.
3. The Essential Qualifications mentioned are the minimum and mere possession of the same does not entitles the candidate to claim selection.
4. The originals of each of the following documents stated below must be brought for verification:
  - a. Photo proof identity card (Passport or Voter ID Card or ADHAR Card or Pan Card).
  - b. Proof of Address (Passport or Voter ID Card or ADHAR Card or Electric Bill of House, Ration Card).
  - c. Age Proof Certificate (Madhyamik or equivalent examination certificate)
  - d. Caste Category Certificate (if any). **In case of OBC candidates category 'A' or 'B' must be mentioned specifically in the caste certificate and last pay slip of the parents.**
  - e. Internship completion certificate.
  - f. Registration Certificate of the Council
  - g. All marksheets starting from Secondary onwards
5. Ratio of candidates to be appointed in BHMS:BAMS:BUMS is 739:167:58 as per previously approved ratio. In case valid application of the respective stream is not available, it may be adjusted from any other stream, keeping the total vacancy position unchanged.
6. On-line registration No. should be retained by all applicants for future reference. Employer is not liable to give any information regarding the on-line registration no. in future.
7. For BHMS/BAMS/BUMS marks obtained in the exam means **total marks obtained in all the years. In case of Supplementary marks should be calculated accordingly.**
8. No **rounding off** of marks will be granted. Proportionate marking upto 2 decimal points will be considered.
9. Claim and/or change of place of posting from the side of the applicant shall not be entertained before /after issuance of appointment letter.
10. Application fees of Rs.200/ for unreserved category and Rs. 100/ for Reserve categories (SC, ST, OBC-A & B and PWD) in the form of Demand Draft to be issued from any Nationalised Bank in favour of West Bengal State Health & Family Welfare Samiti payable at Service Branch, Kolkata.

The hard copy/print copy of the filled up on-line application form of the candidate, after self attestation with date should also be enclosed with the Demand Draft. No application will be accepted without submission of the required Demand Draft. The amount received in the form of Demand Draft will not be refunded.**
