6.0 Examination Fees :

- 6.1 The Examination fee of Rs. 40/- (Rupees forty) only is payable either in form of Demand Draft (DD) / Indian Postal Order (IPO/ Payable at GPO, Kolkata) drawn in favour of **'FA&CAO, Eastern Railway** Kolkata'. This Examination Fee is not refundable / transferable / adjustable under any circumstances.
- 6.2 DDs / IPOs issued before the date of publication of this Employment Notice or after the closing date will not be accepted and the Application Form will be rejected.
- **6.3** Application received with Cash / Cheque / Money order / Central Recruitment Fee Stamps will not be accepted and will be rejected.
